: RESOLUTION :

Under the Government Resolution dated 26-3-1992 referred to in the preamble, Government has powers to fix the tenure of the Chairman or the Member for any period which can also be extended from time to time, but the total period of the tenure so fixed should not exceed 6 years or beyond the age 62 years of the incumbent whichever be earlier, with a view to make this provisions abundantly clear and to clarify the existing position, Government has decided to re-draft the existing sub-clause (2) of the clause 2 as under,

" A Chairman or a Member of the Board shall ~~be~~ hold office for a term as may be fixed by Government; but not exceeding six years from the date on which he enters upon his office, or until he attains the age of sixty two years; whichever is earlier

Provided that Government may extend the said term from time to time, but, however it shall not in any case be beyond the date on which he attains the age of sixty two years;


Provided further that Government may terminate the appointment of a Chairman or a Member at any time before the expiry of the term of his appointment by giving one month's notice in writing;

Provided also that a Chairman or a Member may, by giving one month's notice in his own handwriting, resign from his office at any time before the expiry of the term of his appointment.

The resignation so tendered shall be effective immediately after notice period is over".

3. The other terms and conditions laid down in the above Government resolution shall remain unchanged.
