Dated the 25th Sept. 1998.

The terms and conditions regarding appointment, Pay, Leave, Pension etc of Chairman and Members of Gujarat Subordinate Services Selection Board have been decided under General Administration Department Government Resolution No. KPA/1288/995/G.4 dated 26-3-1992. Consequent upon revision of pay with effect from 1-1-1996, under Revision of pay Rules 1998 of Gujarat State Services it was under consideration of the Government to revise the salary and allowance of Chairman and Members of Gujarat Subordinate Service Selection Board. After careful consideration, Government is pleased to amend the existing sub-para(1) of the Para-3 of the above Government Resolution dated 26-3-1992 as under:

3.(1) Subject to the provisions of this Government Resolution there shall be paid to the Chairman a pay of Rs. 18000/- (Rupees Eighteen thousand only) per mensem and to each of the members a pay of 15000/- (Rupees fifteen thousand only) per mensem plus such allowances as may be admissible on the said pay in the services of State Government from time to time with effect from 1-1-1996.

Provided that a member who may be required to hold the charge of the office of the Chairman during the period of leave or otherwise shall be paid a special pay at the rate of Rs. 900/- (Rupees Nine hundred only)

per mensem in addition to his own salary as a member subject to the condition that his total emolument in that case do not exceed Rs. 18000/- per mensem.

2. The other terms and conditions laid down in the above Government Resolution shall remain unchanged.
